PERFORMANCE WORK STATEMENT

The purpose of this firm fixed price purchase order is to obtain Veterinary Care Services for the Haitian National Police K-9 Unit consisting of 16 Narcotic Canines.

1. DESCRIPTION OF SERVICES

FACILITIES. The contractor must have a clinic in Haiti equipped with sufficient specialized medical and testing equipment to provide any medical attention required to meet the health needs of the canines in the program, to include possible hospitalization should it be deemed necessary, and certified personnel to attend to emergencies on a 24/7 basis.

SERVICES. The contractor must be able to provide a high level and quality of customer service in Haiti, providing monthly visits and maintaining an individual health record for each canine in the program. During each visit, the contractor must check and record in the canines' individual health log:

- Status of ears, teeth, and overall condition of the mouth
- Results of the monthly wellness medical exam
- Status/validity of all vaccines, ensuring that all canines' vaccines are current and up to date
- Flea and tick control (shampoo and collar)
- Status of the canines' nutrition, ensuring that any nutrition issue is immediately addressed to ensure the proper health of the animals
- Emergency services
- Medication and lab work must be included in every visit or hospitalization and emergency handled, to determine illness
- Treatment of minor injuries and illnesses and continuous monitoring of the canines

Services required for sixteen (16) canines (male or female)

- Dog checkups
- Skin treatment products
- Heart worm control
- "Preventic" or equivalent collar
- Flea shampoo
- Medication for specific illnesses of each dog
- Anti-Parasite medication
- Emergency visits including medications, and/or hospitalization. The COR shall order such services on an as needed basis.

In addition to routine monthly medical service, the contractor must be able to attend any emergency due to illness, diseases, injuries, or accidents that may occur during the dog's labor. If a medical emergency presents itself relative to an injured canine, the Vet is expected to respond in a way that will provide treatment to the injured canine promptly. These emergency services listed under the pricing table can only be requested by the COR should the need arise.

The contractor needs to be able to conduct all necessary laboratory tests and provide any applicable surgery should it be deemed necessary or required to ensure the health of the canine.

If the contractor notices any cases of abuse or neglect of the canines, he is required to immediately bring it to the attention of the Contracting Officers Representative (COR).

SUPPLIES. The contractor should be able to provide a variety of dog supplies (flea ointment, shampoo, etc.), canine specific medicines, and canine specific health supplements at reasonable and competitive prices.

TRANSPORTATION. Transportation to and from the contractor's facilities will be provided by the Haitian National Police.

## 2. DELIVERIES OR PERFORMANCE SCHEDULE

The Contractor shall submit a monthly report including the canines' individual health record indicating the services provided to each dog. Reports and any supporting documents must be provided in French or English to the COR.

## 3. PAYMENT

Upon satisfactory performance, the Contractor shall be paid a fixed amount monthly for the services rendered during that period. The Contractor shall include in its next regular invoice details of the Emergency, Medication and Other Services, if applicable. The Contractor shall also include a copy of the COR's written confirmation for the Emergency Services.

## 4. QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

- 4.1. **SURVEILLANCE.** The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.
- 4.2. **STANDARD.** The performance standard is that the Government receives no more than one (1) [Note to Contracting Officer: Insert other number if desired] customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212.4, Contract Terms and Conditions-Commercial Items (May 2001), if any of the services exceed the standard.
- 4.3. **PROCEDURES.**
- (a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.
  - (b) The COR will complete appropriate documentation to record the complaint.
  - (c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.
  - (d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.
  - (e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.
  - (f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.
  - (g) The COR will consider complaints as resolved unless notified otherwise by the complainant.
  - (h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.

- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Predecessor” means an entity that is replaced by a successor and includes any predecessors of the predecessor.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). “Sensitive technology”—

(1) Means hardware, software, telecommunications equipment, or any other technology that is to be used specifically—

- (i) To restrict the free flow of unbiased information in Iran; or
- (ii) To disrupt, monitor, or otherwise restrict speech of the people of Iran; and

(2) Does not include information or informational materials the export of which the President does not have the authority to regulate or prohibit pursuant to section 203(b)(3) of the International Emergency Economic Powers Act ([50 U.S.C. 1702\(b\)\(3\)](#)).

“Service-disabled veteran-owned small business concern”—

(1) Means a small business concern—

(i) Not less than 51 percent of which is owned by one or more service-disabled veterans or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more service-disabled veterans; and
