SECTION 1 - THE SCHEDULE

SCHEDULE OF SUPPLIES/SERVICES / PRICES (Block 20/23) DESCRIPTION/SPECIFICATIONS/WORK STATEMENT

I PERFORMANCE WORK STATEMENT

1. GENERAL

The purpose of this firm fixed price purchase order is to obtain Ambulance Services for the US Embassy in Haiti's staff. The contract will be for a one-year period from the date of the contract award, with **two (2)** one-year options.

2. DESCRIPTION

The Contractor shall provide the Ambulance services described herein to employees of the Government of the United States of America in Port au Prince, Haiti and their dependent. A list of eligible employees who shall be provided this service will be given on contract award.

3. SERVICE REQUIRED

3.1 Responsiveness

The Contractor shall promptly answer all calls for service 24 hours a day, 7 days a week. The ambulance shall quickly arrive at the response site, preferably within 30 minutes after being alerted, per constraints of the local environment, in all areas of Port-au-Prince.

3.2 Trained Staff

The Contractor shall have adequate professional staff for advanced life support response to include first responders, medical providers and drivers. All staff members shall have appropriate training in their respective field.

All medical personal shall have appropriate licensure and certification for their specialty and have the knowledge and language capability to integrate with the Embassy's medical team members as necessary.

3.3 Equipment

All vehicles that will be used for this contract shall be in good working condition. They should be equipped with a navigation unit for assistance in locating response sites and contained the following accessories at a minimum:

- Gurney that can be locked into place
- Oxygen
- Monitoring device(s) for blood pressure, pulse, heart rate and temperature
- Stabilization and trauma supplies (cervical collars, back boards, dressings, splints)

- Advanced Life Support coverage to include defibrillator/pacer and advanced respiratory support capabilities such as intubation and ventilator support, standard IV fluids and medications.

4. ADDITIONAL SERVICES

The contractor shall provide the following additional services with no additional cost to the Government:

- Remote coverage in other areas of Haiti (Cap Haitien, Jacmel, Beach areas)
- In country emergency flight transport
- Phone App or other means for tracking/finding staff location during an emergency

5. ELIGIBLE PARTICIPANTS

5.1 Eligible Employees

5.1.1 Employees eligible for ambulance services include the following:

- All current active employees of the United States Government, employed within the geographic boundaries of Haiti certified by the Contracting Officer. Covered employees include
- Foreign Service Nationals (FSNs) employed under direct hire appointments, Personal Services Agreements (PSAs) and Personal Services Contracts (PSCs);
- Locally hired U.S. citizens employed under direct hire appointments, PSAs, and PSCs.
- Foreign Service Officers and their dependents, Temporary Duty Support US Citizen Direct Hires, other US Citizen contracting support working temporarily in Haiti directly for the United States Embassy.

5.1.2 Location of Employment

The individuals covered must be employed within the geographic boundaries of Haiti.

5.2 Individuals not Eligible for Coverage.

Individuals not eligible for coverage under this contract are non-personal services contract personnel; employees working on a temporary basis via a third (3rd) party contractor and any other individual not falling within one of the categories of employees described in this clause.

5.3 Other Eligible Participants

Covered dependents include the participating employee's spouse and children. A limit of one spouse per employee is covered. An eligible child is defined as the employee's natural child, adopted child, stepchild, or foster child. The child must be unmarried, economically dependent

upon the employee, and reside with the employee unless away at school. An eligible child will be covered until the end of the contract year in which he/she reaches age 18, or age 22 if a full time student. There is no age limit for a child who is physically or mentally handicapped so as to be unable to live independently. There is no limit on the number of children covered per employee.

6. QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

(b) SURVEILLANCE. The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.

(c) STANDARD. The performance standard is that the Government receives no more than one (1) customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212-4, Contract Terms and Conditions-Commercial Items), if any of the services exceed the standard.

(d) PROCEDURES.

(1) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.

(2) The COR will complete appropriate documentation to record the complaint.

(3) The COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.

(4) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.

(5) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.

(6) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.

(7) The COR will consider complaints as resolved unless notified otherwise by the complainant.

(8) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.

II PRICING

1. VALUE ADDED TAX

VALUE ADDED TAX. Value Added Tax (VAT) is not applicable to this contract and shall not be included in the CLIN rates or Invoices because the U.S. Embassy has a tax exemption certificate from the host government.

- (1) Taking or knowingly agreeing to take any action, with respect to the boycott of Israel by Arab League countries, which Section 8(a) of the Export Administration Act of 1979, as amended (50 U.S.C. 2407(a)) prohibits a United States person from taking; or,
- (2) Discriminating in the award of subcontracts on the basis of religion.
