I. PERFORMANCE WORK STATEMENT

The purpose of this firm fixed price purchase order is for maintenance services in all designated system and equipment for real property owned or managed by the U.S. Government at U.S. Embassy Port-au-Prince. The price listed below shall include all labor, materials, insurance (see FAR 52.228-3 and 52.228-5), overhead, and profit. The Government will pay the Contractor the total fixed price amount after standard services have been satisfactorily performed.

After contract award and submission of acceptable insurance certificates, the Contracting Officer shall issue a Notice to Proceed. The Notice to Proceed will establish a date (a minimum of ten (10) days from date of contract award unless the Contractor agrees to an earlier date) on which performance shall start.

The performance period of this contract is from the start date in the Notice to Proceed and continuing for twelve (12) months. The initial period of performance includes any transition period authorized under the contract.

II. PRICING

VALUE ADDED TAX. Value Added Tax (VAT) is not applicable to this contract and shall not be included in the CLIN rates or Invoices because the U.S. Embassy has a tax exemption certificate from the host government.

1. PERFORMANCE WORK STATEMENT

The purpose of this contract is to obtain maintenance services for real property owned or managed by the U.S. Government at U.S. Embassy Port-au-Prince. The Contractor shall perform maintenance services in all designated system and equipment.

1.2 GENERAL REQUIREMENTS

Preventive Maintenance services for major system and equipment installed inside the compound and related to the operation of the U.S. properties are an important part of the representational responsibilities of the U.S. mission. The Government will measure the Contractor's work by the preventive maintenance services provided. These services shall result in all systems being serviced under this agreement being in good operational condition when activated and covered by this contract. The Contractor shall perform complete maintenance services as described in this contract for all Government properties. The Contractor shall include all planning, administration, and management necessary to assure that all services comply with the contract, the COR's schedules and instructions, and all applicable laws and regulations. The Contractor shall meet all of the standards of performance identified in the contract. The Contractor shall perform all related support functions such as supply, subcontracting, quality control, financial oversight, and maintenance of complete records and files.

1.2.1. DUTIES AND RESPONSIBILITIES

1.2.1.1 The compound requires an access authorization and can only be entered during scheduled times. The General Instructions shall emphasize security requirements so that accidental security violations do not occur.

1.2.1.2 Contractor shall schedule routine work requirements to ensure that these are done in the order and time frame that are most efficient and have the least impact on normal operations.

1.2.2. DEPARTMENT OF STATE (DOS) POLICIES, REGULATIONS, AND STANDARDS

Requirements of the Department of State Safety, Health, and Environmental Management Resource Guide include adherence to work practices and procedures stated in applicable codes and regulations. Requirements include obtaining permits, licenses, inspections, releases and similar documentation, as well as payments, statements and similar requirements associated with codes and regulations.

### 1.2.3. CONTRACTOR RESPONSIBILITY

The Contractor:

- Shall assume full responsibility and liability for the compliance with all applicable DOS policies, regulations, and standards in their most current form.
- Shall hold the U.S. Government and its representatives harmless for failure to comply with any applicable work, hauling, disposal, safety, health or other regulations on the part of the Contractor, their employees, or subcontractors.

### 1.3. MANAGEMENT AND SUPERVISION

1.3.1. SUPERVISION. The Contractor shall designate a representative who shall be responsible for on-site supervision of the Contractor's workforce at all times. This supervisor shall be the focal point for the Contractor and shall be the point of contact with U.S. Government personnel. The supervisor shall have sufficient English language skill to be able to communicate with members of the U.S. Government staff. The supervisor shall have supervision as his or her sole function.

1.3.2. SCHEDULES. The Contractor shall maintain work schedules. The schedules shall take into consideration the hours that the staff can effectively perform their services without placing a burden on the security personnel of the Post. The Contractor shall deliver standard services between the hours of 7:00 AM and 3:30 PM Monday through Friday and from 7:00AM to 12:00 PM on Saturday. For those items other than routine daily services, the Contractor shall provide the COR with a detailed plan as to the personnel to be used and the time frame to perform the service.

1.3.3. QUALITY CONTROL. The Contractor shall be responsible for quality control. The Contractor shall perform inspection visits to the work site on a regular basis. The Contractor shall coordinate these visits with the COR. These visits shall be surprise inspections to those working on the contract.

1.3.4. TECHNICAL GUIDANCE. The Contractor shall have the services of qualified personnel with experience in building and operation maintenance locally to give technical guidance to the Contractor's work force and to develop and guide the Contractor's programs to maintain major system as AC units, Pool, Tennis court, Plumbing system, Water filtration/chlorination system.

1.3.5. PERFORMANCE STANDARD. The Contractor shall submit an annual Maintenance Plan that reflects the proposed frequency for meeting the requirements of this contract. The

Maintenance Plan will be developed to reflect system and equipment. They should be clean and in good operating condition upon completion of the service. The preventive maintenance service shall result in the parts of the system serviced being in a condition to operate efficiently and effectively. The Contractor shall submit the Maintenance Plan to the COR for approval within 30 days after contract award.

1.3.6. SAFETY AND MATERIALS. The Contractor shall inventory, supply and replace expendable parts (eg, filters, belts, hoses, gaskets) that have become worn due to wear and tear. The Contractor shall maintain a supply of expendable and common parts on site so that these are readily available for normal maintenance to include: hoses, belts, chemicals, cleaning supplies, water hoses, grease, sealant, thermostat, fuses; in addition to the appropriate tools, testing equipment, safety shoes and apparel for technicians, personal protective equipment (hands, hearing, eye protection), MSDS, cleaning material and oil spill containment kits. The contractor shall inventory the supply after each visit and order replacement supplies and have them delivered on site. Maintenance materials shall be unused and are to be industry standard and intended for the task to be performed. Parts shall be OEM approved. Refrigerants shall meet the AHRI Standard 700-2015 or most recent AHRI Standards.

#### 1.4 AC MAINTENANCE

1.4.1. REGULAR SERVICE. The Contractor shall service periodically all AC units located in the residences, the club house, the main access entrance and the administrative office. The frequency should be at least every two months. The Contractor is responsible for all equipment, tools and materials needed to complete this task. The regular service should include but not limited to cleaning of the screen filters, cleaning coil and fan with water hose, cleaning of the condensing unit.

1.4.2 SPECIAL SERVICE. The Contractor shall answer at most in 48 hours to a service call for a defective unit or a nonfunctional unit. They shall perform all troubleshooting based on the symptom and provide a recommendation for a repair or replacement of the unit if necessary. The troubleshooting will include and not limited to testing refrigerant level, testing cooling load, testing voltage from compressor, and troubleshooting and diagnostics fault on units.

1.4.3. INSTALLATION. The Contractor shall remove old or defective units, replace and install new units when requested by the COR or Embassy approved personnel. New units will be provided by Embassy and contractor shall return all old units to Embassy personnel / AC technician.

## 1.5. CLEANING OF VARIOUS AREAS OF THE COMPOUND

1.5.1 Contractor will perform the cleaning services while prepping the area and gathering all their necessary cleaning materials and load them onto their janitorial cart. Contractor will place any caution or wet floor signs that are necessary if they are going to be mopping or doing any other kind of extensive cleaning

1.5.2. The Contractor shall prepare a written schedule, as part of the Maintenance Plan, showing the method, frequencies, and dates of compound cleaning.

1.5.3. The cleaning service shall include but not limited to:

1.5.3.1. Cleaning on a regular basis all drains at the Club House, Restrooms, Compound Entrance, Pool, Tennis Court and Kids Playground Areas

1.5.3.2. Club House, Restrooms, Compound Entrance:

- Dust mop tiled areas using a treated dust mop.
- Broom and sweep all interior area, remove spider webs from ceiling.
- Clean walls, metallic doors frame with an all-purpose cleaner.
- Dust mop, sweep, and then wet mop the vestibule, entrance and any other hard floored surface ,clean glass windows and glass door with a glass cleaner to remove all fingerprints and smudges.

1.5.3.3. Club House:

- Clean all windows, counter top and appliances.
- Vacuum all sofa furniture.
- Vacuum or damp wipe furniture using an all-purpose cleaner.

1.5.3.3. Restrooms:

- Clean and scrub all interior surfaces of toilets, urinals, showers with a toilet bowl cleaner. Wipe down all exterior surfaces, including toilet seats, with a disinfectant. Clean all exterior toilet and showers.

1.5.3.4. Kid's Playground:

- Clean, wash turf and maintained the area out of floating debris.

1.5.3.5. Tennis Court:

- Broom and clean the tennis court.

## 1.6. GARBAGE COLLECTION

Garbage collection should be part of the Maintenance Plan.

The Contractor shall perform complete trash pick services and properly dispose of the bags outside the compound as described in this contract for the following areas: Club House and all residences, Restrooms, Compound Entrance, Pool Area, Tennis Court and Kids Playground Areas.

The Contractor shall schedule routine pickup requirements to ensure that these are done in the order and timeframe that are most efficient and have the least impact on normal operations. Scheduled Services shall include pickup service in all designated areas of the compound. The Contractor shall provide sufficient trash bags to each location.

The Contractor is also responsible for all logistics and expenses incurred in the collection and disposal of household trash. No storage facility or dumpster will be provided by the Government.

## 1.7. CHLORINATION OF POTABLE WATER.

The Contractor shall, on a weekly basis, test the level and concentration of the chlorine from cistern. The contractor will adjust accordingly based on results found after the test. The contractor shall maintain the water filtration system in good operating condition.

## 1.8. REMOVAL OF DEBRIS.

The Contractor shall remove foreign material, paper, and trash from the maintained areas including roadways, walkways, stairways and curbs within or adjacent to the area. The Contractor shall remove all debris and equipment from the work site before the end of each workday. Debris removal shall prevent unsightly accumulation. The Contractor shall promptly remove collected debris from the premises. No storage facility or dumpster will be provided by the Government. The Contractor is responsible for all expenses incurred in the collection and disposal of debris. Trash bags collected per house could be estimated at two (2) 50 gallon bags per house.

## 1.9. POOL MAINTENANCE

1.9.1 MATERIALS AND EQUIPMENT. The contractor is responsible to provide the pool with testing equipment for the determination of disinfectant residuals and pH concentration specific to the disinfecting agent being used. The disinfectant residual tester shall have a range of at least 0.0 to 5.0 mg/l. The pH tester shall be able to indicate pH between 6.0 and 8.0. Test kit

chemicals shall be replaced according to manufacturer's recommendations. Chemicals must be stored in accordance with manufacturer's recommendations.

The pool has a capacity of 72,000 gallons / 273 m<sup>3</sup>.

#### 1.9.2 STANDARD QUALITY.

Pool water must be maintained at the following minimum values:

- a. PH between 7.2 and 7.8.
- b. Maintain a free chlorine residual of 1-3 mg/l
- c. Total chlorine residuals shall be no greater than 1 milligram per liter above free chlorine levels. (Break Point chlorination shall be performed when total chlorine residuals are 1 mg/l or greater.)

1.9.3 REGULAR SERVICE. The contractor is responsible to maintain the pool including the water circulation system, the cleaning materials, chemicals and provide proper storage area. On a daily basis the contractor shall inspect and perform the following check:

- Checked the recirculation system and assured an operation continually 24 hours per day.
- The pool surface should be kept free of floating dirt and film and the pool bottom free of sediment using a leaf skimmer or leaf rake.
- Vacuum the pool. The pool will be vacuumed every visit as heavy use or wind and rain will bring in an extra heavy dose of debris. The vacuum hose must be filled with water before it is attached to the filter line. If a nylon brush is part of the vacuum head, it shall be adjusted so it touches the floor and dislodges embedded dirt. When the wheels and brushes are so worn that they can no longer be adjusted, they shall be replaced.
- Splash water on the tile and pick up leaves and other debris. Clean tile and walls. The scum that forms on the tile at the waterline shall be cleaned with special tile cleaners that can be applied with a brush. Never use steel wool to clean tile because the iron particles can stain the finish. Remove light scale deposits from tile. Brush the walls in a uniform manner with a tough enough brush to remove the dirt that clings to the walls. Check and clean strainer baskets (skimmers) and hair/lint pot (pump). Before vacuuming and backwashing, make sure all debris is removed from the strainer baskets and hair lint pots to ensure maximum suction
- Backwash and service/replace the filter. The equipment will be backwashed regularly and thoroughly to guarantee its optimum state. In case that replacement is needed the contractor shall provide a quote to COR and Embassy will provide the required parts.
- Perform water testing and add chemicals as needed. Depending on the results of the water testing, chemicals might be needed to guarantee the water quality is within the safety requirements.

- Control and check daily the pool pump, pump motor, sand filters, strainers and related system. All these equipment should be in good operating condition. Strainer from the pool pumps should be free of debris and clean as necessary. The contractor must thoroughly check this equipment as part of the regular cleaning procedure and correct minor problems as they arise. In case the detected problem is major the contractor will report this to the COR. Refer to manufacturer's product manual when working with any piece of equipment.
- Clean coping and decking. Use nonabrasive cleaners and sweep away from pool. Acceptable methods for cleaning outdoor pool decks are hosing and mopping. Hosing and cleaning movement must be directed away from the pool to prevent debris from collecting around its edge or from being blown into it. High-pressure cleaning and scrubbing are accepted practices for maintaining nonslip decks
- The contractor must leave all the pool area in the same or better state from the way it is received
- Maintain PH and chlorine level per the standard specifications, the contractor will add chemicals as required after test was done. Chlorination level should be maintained between :0.2-0.5 mg/l. Ph level should be maintained at :6.5-8.5
- Record daily the operation of the recirculating system, chemical additions, bather load, PH, and disinfectant residuals and monthly microbiological results shall be kept at the pool facility. Records must be available for inspection by interested parties during normal pool operating hours.

1.9.3 SPECIAL SERVICE. The contractor shall provide service in case the pool starts to be green, PH is out of balance or Chlorine level is too high or too low. All calls shall be answered in less than 24 hours.

#### 1.10 GENERATOR SUPPORT

1.10.1 ROUTINE CHECK. The contractor should perform a routine check of the generators at least every day; this should include at a minimum the following:

1. Perform a visual inspection of the generator(s) running and surrounding area.
2. Check engine oil level with dipstick.
3. Check coolant level in radiator tank
4. Check battery electrolyte level.
5. If standby status, check operation of engine block water heater and oil heater.
6. Read and record engine hour meter.
7. Check fuel level in storage and day tank.
8. Test start unit.
9. Check unit for abnormal noise and vibration.

10. Check water level from cistern and make sure there are no water leaks in the utility room. The well should be started manually if level is low. The cistern capacity is 30,000 gallons.

11. Check day tank and main fuel tank level. Refill day tank if level is low.

1.10.2 EMERGENCY SERVICE. The Contractor shall answer any emergency call in less than 1 hour of a generator failure or a nonfunctional engine or water pump failure. Contractor shall perform all troubleshooting based on the symptoms and provide a recommendation for a repair if necessary. In case of an overnight emergency and power is not restored within 30 minutes, a qualified personnel should come on site and manually start backup generators if automatic system failed.

Technician on site shall alert Embassy duty tech at 3464-9223 for any generator fuel and/or water shortage or other related failure noticed while performing routine check.

Technician shall check and reset all alarm related to generator, water distribution system, grinding pump, water level and alarm located in residential house.

## 1.12 LOCATION FOR THE MAINTENANCE SERVICES

All standard services are to be delivered on regular Post working days.

## 2. WORKING HOURS

All work shall be performed during Monday through Saturday, between 7:00 AM and 3:30 PM except for the holidays identified in the Addendum in Section 2. Other hours may be approved by the Contracting Officer's Representative. The Contractor must provide at least 24 hour advance notice to the COR who will consider any deviation from the hours identified above.

#### 4. PERSONNEL REQUIREMENTS

4.1 GENERAL. The Contractor shall maintain discipline at the site and shall take all reasonable precautions to prevent any unlawful, riotous or disorderly conduct by Contractor employees at the site. The Contractor shall preserve peace and protect persons and property on site. The Government reserves the right to direct the Contractor to remove an employee from the worksite for failure to comply with the standards of conduct. The Contractor shall immediately replace such an employee to maintain continuity of services at no additional costs to the Government.

#### 4.2 STANDARD OF CONDUCT

4.2.1 Uniforms and Personal Equipment. The Contractor's employees shall wear clean, neat and complete uniforms when on duty. All employees shall wear uniforms approved by the Contracting Officer's Representative (COR).

4.2.2 Neglect of duties shall not be condoned. The Contractor shall enforce no sleeping while on duty, unreasonable delays or failures to carry out assigned tasks, conducting personal affairs during duty hours and refusing to render assistance or cooperate in upholding the integrity of the worksite security.

4.2.3 Disorderly conduct, use of abusive or offensive language, quarreling, intimidation by words, actions, or fighting shall not be condoned. Also included is participation in disruptive activities, which interfere with normal and efficient Government operations.

4.2.4 Intoxicants and Narcotics. The Contractor shall not allow its employees while on duty to possess, sell, consume, or be under the influence of intoxicants, drugs or substances that produce similar effects.

Criminal Actions. Contractor employees may be subject to criminal actions as allowed by law in certain circumstances. These include but are not limited to the following actions:

- Falsification or unlawful concealment, removal, mutilation, or destruction of any official documents or records or concealment of material facts by willful omission from official documents or records;
- Unauthorized use of Government property, theft, vandalism, or immoral conduct;
- Unethical or improper use of official authority or credentials;
- Security violations; or,
- Organizing or participating in gambling in any form.

4.2.5 **KEY CONTROL.** The Contractor shall receive, secure, issue and account for any keys issued for access to buildings, offices, equipment, gates, etc., for the purposes of this contract. The Contractor shall not duplicate keys without the COR's approval. Where it is determined that the Contractor or its agents have duplicated a key without permission of the COR, the Contractor shall remove the individual(s) responsible from this contract. If the Contractor has lost any such keys, the Contractor shall immediately notify the COR. In either event, the Contractor shall reimburse the Government for the cost of rekeying that portion of the system.

#### 4.3. NOTICE TO THE GOVERNMENT OF LABOR DISPUTES

The Contractor shall inform the COR of any actual or potential labor dispute that is delaying or threatening to delay the timely performance of this contract.

#### 4.4. PERSONNEL SECURITY

4.4.1 After award of the contract, the Contractor shall provide the following list of data on each employee who will be working under the contract. The Contractor shall include a list of workers and supervisors assigned to this project. The Government will run background checks on these individuals. It is anticipated that security checks will take 30 days to perform. For each individual the list shall include:

- Full Name
- Place and Date of Birth
- Current Address
- Identification number
- Vehicle plate number and model

4.4.2 Government shall issue identity cards to Contractor personnel, after they are approved. Contractor personnel shall display identity card(s) on the uniform at all times while providing services under this contract. These identity cards are the property of the US Government. The Contractor is responsible for their return at the end of the contract, when an employee leaves

Contractor service, or at the request of the Government. The Government reserves the right to deny access to U.S.-owned and U.S.-operated facilities to any individual.

## 5. MATERIALS AND EQUIPMENT

The Contractor shall provide all necessary managerial, administrative and direct labor personnel, as well as all transportation, equipment, tools, supplies and materials required to perform inspection, maintenance, and component replacement as required to maintain the systems in accordance with this work statement.

## 6. INSURANCE

6.1 AMOUNT OF INSURANCE. The Contractor is required to provide whatever insurance is legally necessary. The Contractor shall, at its own expense, provide and maintain during the entire performance period the following insurance amounts:

6.2 GENERAL LIABILITY (includes premises/operations, collapse hazard, products, completed operations, contractual, independent contractors, broad form property damage, personal injury)

1. Bodily Injury stated in US Dollars:

2. Property Damage stated in US Dollars:  
Cumulative \$100,000.00

6.3 The types and amounts of insurance are the minimums required. The Contractor shall obtain any other types of insurance required by local law or that are ordinarily or customarily obtained in the location of the work. The limit of such insurance shall be as provided by law or sufficient to meet normal and customary claims.

6.4 For those Contractor employees assigned to this contract who are either United States citizens or direct hire in the United States or its possessions, the Contractor shall provide workers' compensation insurance in accordance with FAR 52.228-3, or host country nationals that do not have a DOL waiver.

6.5 The Contractor agrees that the Government shall not be responsible for personal injuries or for damages to:

- any property of the Contractor,
- its officers,

- agents,
- servants,
- employees, or
- any other person,
- arising from an incident to the Contractor's performance of this contract. The Contractor shall hold harmless and indemnify the Government from any and all claims arising, except in the instance of gross negligence on the part of the Government.

6.6 The Contractor shall obtain adequate insurance for damage to, or theft of, materials and equipment in insurance coverage for loose transit to the site or in storage on or off the site.

6.7 Government as Additional Insured. The general liability policy required of the Contractor shall name "the United States of America, acting by and through the Department of State," as an additional insured with respect to operations performed under this contract.

6.8 Time for Submission of Evidence of Insurance. The Contractor shall provide evidence of the insurance required under this contract within ten (10) days after contract award. The Government may rescind or terminate the contract if the Contractor fails to timely submit insurance certificates identified above.

## 7. LAWS AND REGULATIONS

7.1 Without additional expense to the Government, the Contractor shall comply with all laws, codes, ordinances, and regulations required to perform this work. If there is a conflict between the contract and requirements of local law, the Contractor shall promptly advise the Contracting Officer of the conflict and of the Contractor's proposed course of action for resolution by the Contracting Officer.

7.2 The Contractor shall comply with all local labor laws, regulations, customs and practices pertaining to labor, safety, and similar matters, unless they are inconsistent with the requirements of this contract.

## 8.0. TRANSITION PLAN

Within 10 days after contract award, the Contracting Officer may ask the Contractor to develop a plan for preparing the new Contractor to assume all responsibilities for operation and maintenance services. The plan shall establish the projected period for completion of all clearances of contractor personnel, and the projected start date for performance of all services required under this contract. The plan shall assign priority to the selection of all supervisors to be used under the contract.

## 9.0 QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

1. **SURVEILLANCE.** The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.
2. **STANDARD.** The performance standard is that the Government receives no more than one (1) [Note to Contracting Officer: Insert other number if desired] customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212.4, Contract Terms and Conditions-Commercial Items (May 2001), if any of the services exceed the standard.
3. **PROCEDURES.**
  - (a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.
  - (b) The COR will complete appropriate documentation to record the complaint.
  - (c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.
  - (d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.
  - (e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.
  - (f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.

(g) The COR will consider complaints as resolved unless notified otherwise by the complainant.

(h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.

Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. (1) A citizen or resident of the United States;

(2) A domestic partnership;

(3) A domestic corporation;

(4) Any estate (other than a foreign estate, within the meaning of 26 U.S.C. 701(a)(31)); and

(5) Any trust if—

(i) A court within the United States is able to exercise primary supervision over the administration of the trust; and

(ii) One or more United States persons have the authority to control all substantial decisions of the trust.

(b) Unless exempted, there is a 2 percent tax of the amount of a specified Federal procurement payment on any foreign person receiving such payment. See 26 U.S.C. 5000C and its implementing regulations at 26 CFR 1.5000C-1 through 1.5000C-7.

(c) Exemptions from withholding under this provision are described at 26 CFR 1.5000C-1(d)(5) through (7). The Offeror would claim an exemption from the withholding by using the Department of the Treasury Internal Revenue Service Form W-14, Certificate of Foreign Contracting Party Receiving Federal Procurement Payments, available via the internet at [www.irs.gov/w14](http://www.irs.gov/w14). Any exemption claimed and self-certified on the IRS Form W-14 is subject to audit by the IRS.
