1.0 GENERAL

The purpose of this procurement is to replace fuel dispensing equipment for US Embassy Haiti's vehicle fleet.

1.1. DESCRIPTION

The offeror shall provide all labor and materials to execute the following:

- Remove three (3) existing fuel dispensing equipment including accessories as indicated on scope. All old equipment shall be returned to Embassy for disposal.
- Verify location of equipment conforms to requirements of Chapter 13 of the OBO Mechanical Code (Attachment 1)
- Install wiring in conduit with long radius bends at all changes in direction.
- Provide and install new equipment with dispenser sumps according to manufacturer's written instructions.to be connected to existing underground fuel storage tanks, automatic fueling management systems and emergency shutoff systems.

Vehicular Fuel Dispensers Specifications

A. Design:

1. Single Product, Single Hose: remote dispenser. (Gasoline)
2. Dual Product, Dual Hoses: (Diesel and Gasoline)

B. Description: Fuel dispenser for commercial and industrial applications, ready to operate with card and key-lock systems.

C. Features:

1. Electronic Totalizer; 7,571,000 liters.
2. Pumping Unit with Vortex Air Eliminator: 14 GPM nominal flow rate, 1/3 HP intermittent duty motor, 115/230V, 60/50 Hz.

The government shall remain the sole proprietor of this new equipment.

2.0 INSTALLATION AND OPERATION

2.1 TESTING

Before installation of the equipment, the dispensers shall be tested for performance and proper fronting of control and interfacing circuits. Tests shall include verifying all safety shutdowns and components are functioning properly.

2.2 START-UP SERVICE

Only manufacturer's factory certified technician shall perform start-up service. Start-up service shall be provided for Electronic Fuel Management Systems (for vehicular fuel dispensing). Notify the Contracting Officer Representative (COR) 14 days in advance of performing startup field testing.

1. Inspect field-assembled components and electrical connections for proper assemblies, installations, and connection.
2. Complete installation and perform start-up check according to manufacturer's written instructions.
3. Verify that installation complies with Construction Documents.

2.3 TRAINING

1. Training shall be performed at project site. Schedule training with COR with at least fourteen days advance notice.
2. Train Government maintenance personnel on procedures and schedules for starting and stopping, operating, troubleshooting, servicing, and maintaining equipment and schedules.
3. Review data in manufacturer supplied maintenance manuals, and site-specific operations and maintenance plan.

2.4 OWNERS MANUALS

Two (2) sets of owner's manuals specific to the fuel meters and products supplied shall accompany the equipment. General operating instructions, preventive maintenance, wiring diagrams, schematics and parts exploded views specific to this model shall be included. A PDF version of the owner's manuals shall also be provided on a compact disc.

2.5 SPARES

The offer shall include a complete list of spare parts required for each element of fuel system.

2.6 REFERENCE STANDARDS

National Fire Protection Association (NFPA) 30: Flammable and Combustible Liquids Code and NFPA 31: Standard for the Installation of Oil Burning Equipment.

2.7 SYSTEM REQUIREMENTS

Fuel dispensing equipment shall conform to Chapter 13 of the OBO Mechanical Code (International Mechanical Code as amended by OBO).

2.8 SUBMITTALS

A. Product Data: For the following:

Vehicular fuel dispensers and fuel management system.

B. Shop Drawings: Submit shop drawings for the following:

Dispensers: Include elevation view of dispenser and dispenser containment sump. Identify all component connections, including for piping, power, and monitoring.

C. Qualification Data: For manufacturer and installer.

D. Field Report: For start-up service recording inspections and results of tests.

E. Installation Instructions and Checklists: Include Manufacturer's installation instructions for fuel dispensers and fuel management system

F. Maintenance Data: For vehicular fuel dispensing system, include list showing recommended maintenance frequency for system components.

2.9 WARRANTY

Manufacturer's standard form in which manufacturer agrees to repair or replace components that fail in materials or workmanship within specified warranty period.

Electronic Fuel Management System for Vehicular Fuel Dispensing:
Warrant functionality of read/write keys. Provide technical support via telephone for diagnostics and assistance. Warranty Period should be five (5) years.

3.0 SCHEDULING

The offeror shall complete the work within 90 calendar days after the Notice To Proceed (NTP) is issued.

4.0 QUALITY OF WORK/QUALITY ASSURANCE

The offeror will be solely responsible for the quality of the work; therefore, any damage, defect, necessary repair, or improperly electrical wiring will be his responsibility.

A. Basis of Design: This Section identifies “Basis of Design” for various equipment and components. Other products from the identified manufacturer or other manufacturers are acceptable which conform to requirements of this Section.

B. Comply with the Electrical Code (NFPA 70, “National Electrical Code”).

C. Listing and Labeling: Provide voltage regulators specified in this Section that are listed and labeled. Terms "Listed" and "Labeled" shall be as defined in Article 100 of NFPA 70. Listing and Labeling Agency Qualifications: "Nationally Recognized Testing Laboratory" as defined in OSHA Regulation 1910.7

D. Manufacturer Qualifications: Manufacturers shall have produced similar systems for at least the past ten years.

E. Installer Qualifications: Installers who have been trained and certified by manufacturer for installation of systems required for this project.

5.0 ASBESTOS-CONTAINING MATERIALS RESTRICTION

Asbestos-free materials shall be used. The Government reserves the right at no additional cost to the Government to disapprove and to disallow the installation of any item containing asbestos.

6.0 OPERATIONS AND STORAGE AREAS

The offeror must have appropriate storage on site for described equipment. Stored materials must stay clean, free of grease, oil, paint and any other foreign matter that could reduce their quality and must be used in the manner, quantity and inclination recommended by the manufacturer. Security

and operation of the storage area is the sole responsibility of the offeror. Materials that do not meet quality or esthetic requirements will be returned at the cost of the offeror.

7.0 CONFINEMENT TO AUTHORIZED AREAS

Offeror is only authorized in those areas of the US Embassy site that are designated as the installation site and laydown yard.

8.0 PROTECTION OF PROPERTY

Offeror shall insure that installation procedures are in place to reduce the destruction of any adjacent structure. Any damage shall be corrected at the offeror's expense.

9.0 SECURITY

The Offeror shall maintain continuous coordination and constant communication with the COR. The Offeror shall observe all rules and follow all directions given by the End User pertaining to security. The Offeror shall protect and retain responsibility for all work, workers, and secure all materials until installation is complete and have been accepted.

The Offeror shall provide valid identification for all personnel.

10.0 GENERAL CLEAN UP

This specification refers to clean up during Installation and at the end of the job. During the entire installation period, there must be places previously agreed upon with INL or the end user where disposed materials can be discarded.

11.0 INSURANCE

11.1 AMOUNT OF INSURANCE. The Contractor is required to provide whatever insurance is legally necessary. The Contractor shall, at its own expense, provide and maintain during the entire performance period the following insurance amounts:

11.2 The types and amounts of insurance are the minimums required. The Contractor shall obtain any other types of insurance required by local law or that are ordinarily or customarily obtained in the location of the work. The limit of such insurance shall be as provided by law or sufficient to meet normal and customary claims.

11.3 For those Contractor employees assigned to this contract who are either United States citizens or direct hire in the United States or its possessions, the Contractor shall provide workers' compensation insurance in accordance with FAR 52.228-3, or host country nationals that do not have a DOL waiver.

11.4 The Contractor agrees that the Government shall not be responsible for personal injuries or for damages to:

- any property of the Contractor,
- its officers,
- agents,

- servants,
- employees, or
- any other person,
- arising from and incident to the Contractor's performance of this contract. The Contractor shall hold harmless and indemnify the Government from any and all claims arising, except in the instance of gross negligence on the part of the Government.

11.5 The Contractor shall obtain adequate insurance for damage to, or theft of, materials and equipment in insurance coverage for loose transit to the site or in storage on or off the site.

11.6 Government as Additional Insured. The general liability policy required of the Contractor shall name "the United States of America, acting by and through the Department of State," as an additional insured with respect to operations performed under this contract.

11.7 Time for Submission of Evidence of Insurance. The Contractor shall provide evidence of the insurance required under this contract within ten (10) days after contract award. The Government may rescind or terminate the contract if the Contractor fails to timely submit insurance certificates identified above.

12. LOCATION AND SCHEDULE

All dispensers will be installed at the American Embassy, Tabarre road

- A. One (1) Diesel and Gasoline dispenser with dual product, dual Hoses will be installed near the garage.
- B. Two (2) Gasoline Dispensers, with single product, single hoses will be installed near the car wash area.

The Contractor shall perform the work at the site Monday thru Friday during the hours of 7:00 am to 3:30 pm, unless agreed upon with the COR.

Work shall be done in such a way not to disrupt normal Embassy Operations.

14.2 VALUE ADDED TAX

VALUE ADDED TAX. Value Added Tax (VAT) is not applicable to this contract and shall not be included in the CLIN rates or Invoices because the U.S. Embassy has a tax exemption certificate from the host government.

15.0 QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

SURVEILLANCE. The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.

STANDARD. The performance standard is that the Government receives no more than one (1) customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212.4, Contract Terms and Conditions-Commercial Items (May 2001), if any of the services exceed the standard.

PROCEDURES.

- (a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.
- (b) The COR will complete appropriate documentation to record the complaint.
- (c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.
- (d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.
- (e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.
- (f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.
- (g) The COR will consider complaints as resolved unless notified otherwise by the complainant.
- (h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.

CHAPTER 13 FUEL OIL PIPING AND STORAGE

SECTION 1301 GENERAL

Add the following subsections:

1301.1.1 Fuel oil storage requirements. Provide minimum fuel storage in accordance with the following.

1301.1.1.1 Fuel oil compound storage capacities. Provide a minimum of two compound fuel tanks sized to contain the larger of:

1. Adequate fuel to run site generators and boilers, simultaneously operating, at full load capacity for a minimum of seven day, 24 hour operation; or
2. Additional capacities as required on a site-specific basis.
3. Each tank shall not be sized larger than 38,000 L.

1301.1.1.2 Required day tank storage capacities. Provide a day tank for each piece of equipment (generator, boiler). Each day tank shall be sized to provide an 8 hour fuel supply for the equipment being served.

1301.1.1.3 Fuel polishing system. Provide fuel polishing system to extend service life of stored fuel oil used by generators.

Add the following subsections:

1301.6 Propane, Butane or Other Liquefied Flammable Gases. Propane, butane or other liquefied flammable gases in portable containers shall not be stored or used in any occupancy used for office or living purposes. They may be used, as permitted by the *International Fire Code* in workshops for approved industrial purposes.

1301.6.1 Piping. When specifically approved for use by OBO, all piping for liquefied flammable fuel shall be rigid or semi-rigid and approved by a recognized testing laboratory for such use.

1301.6.2 Residential Occupancies. In Group R Occupancies liquefied flammable gas storage cylinders shall not be stored or located inside a dwelling.

1301.6.2.1 Cylinder storage. Cylinders shall be located a minimum of 7.62 m away from any source of ignition.

1301.6.2.2 Appliances. All natural gas or liquefied flammable gas appliances shall be rated and equipped by the manufacturer for the specific type fuel to be used.

1305.2.2 Additional requirements. Provide the following.

1305.2.2.1 Fuel line minimum slope. All fuel lines shall be sloped to drain into either the underground storage tank or a vault with the capacity to store the line displacement.

1305.2.2.2 Storage vault. Where a storage vault is installed, provide the following.

1. Leak detection system to detect fuel and communicate alarm to [POST 1] and [FM office].
2. Alarm activation shall disable the supply pump.
3. Vault shall be constructed to prevent run-off and to prevent groundwater from entering the vault.
4. Vault shall be equipped with a lockable cover.

1305.4 Return piping. Provide the following.

1. All day tanks shall be equipped with gravity-feed return lines connected to the main fuel oil storage tank to protect against over-filling.
2. Return line suction shall be connected to the day tank at a point below the level of the vent connection to the tank, and below any other tank openings so that any excess fuel oil will be returned to the main storage tank before reaching overflow level in the day tank.

3. Return lines shall be sized to handle the maximum flow from the supply pump.
4. When gravity return is not possible due to site issues, i.e. hilly site and underground fuel storage tanks buried at elevation above the day tank, provide pumped return lines from the day tank to the underground fuel oil storage tanks with fuel oil return pump sized at 150%-200% of the design flowrate of the fuel oil supply pump.

Add the following section:

SECTION 1309
VEHICLE FUEL DISPENSING SYSTEMS

1309.1 Location. Vehicle fuel dispensing devices shall be located a minimum distance of 3 meters from property lines or any building which is less than 1-hour fire resistive construction, and at least 5 meters from any building doors. Dispensing devices shall also be located so that the nozzle, when hose is fully extended, shall not reach within 1500 mm of any building opening.

1. Dispensing Units shall be at least 6000 mm from all fixed sources of ignition.

1309.2 Dispensing Island. All dispensing devices shall be protected against physical damage from vehicles by mounting on a concrete island a minimum of 150 mm in height, with 3100 mm high bollards at each end of the island.

1309.3 Emergency Breakaway Devices. Provide UL-listed devices for each hose.

1309.4 Emergency Shutoff Valve. Install UL-listed valve in the supply line of each dispensing device incorporating a fusible or other thermally actuated device as a protection against impact or seismic occurrences.

1309.5 Electrical Controls. Controls shall be provided with standard U.S. safety features. The controls shall permit the pump to operate only when a dispensing nozzle is either removed from its bracket or is in normal position with respect to the dispensing unit, and the switch is manually actuated. This control shall also stop the pump when all nozzles have been returned, either to their brackets or to the normal dispensing position. In addition, electrical controls shall comply with the following:

1. Master Switch. A clearly labeled manually operated pump master switch shall be provided in an approved location, within 30m of but not nearer than 6 m to, any dispenser. Where such master switch is not visible from all dispensers, the location shall be indicated by approved signs.

2. Provide signs identifying the pump master switch labeled "EMERGENCY FUEL SHUTOFF."

(c)(1) If the Contractor is a foreign person and has only a partial or no exemption to the withholding, the Contractor shall include the Department of the Treasury Internal Revenue Service Form W-14, Certificate of Foreign Contracting Party Receiving Federal Procurement Payments, with each voucher or invoice submitted under this contract throughout the period in which this status is applicable. The excise tax withholding is applied at the payment level, not at the contract level. The Contractor should revise each IRS Form W-14 submission to reflect the exemption (if any) that applies to that particular invoice, such as a different exemption applying.

- (4) PSG 89, Subsistence;
- (5) PSC 9410, Crude Grades of Plant Materials;
- (6) PSC 9430, Miscellaneous Crude Animal Products, Inedible;

- (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

(2) A domestic partnership;

(3) A domestic corporation;

(4) Any estate (other than a foreign estate, within the meaning of 26 U.S.C. 701(a)(31)); and

(5) Any trust if—

(i) A court within the United States is able to exercise primary supervision over the administration of the trust; and

(ii) One or more United States persons have the authority to control all substantial decisions of the trust.

(b) Unless exempted, there is a 2 percent tax of the amount of a specified Federal procurement payment on any foreign person receiving such payment. See 26 U.S.C. 5000C and its implementing regulations at 26 CFR 1.5000C-1 through 1.5000C-7.

(c) Exemptions from withholding under this provision are described at 26 CFR 1.5000C-1(d)(5) through (7). The Offeror would claim an exemption from the withholding by using the Department of the Treasury Internal Revenue Service Form W-14, Certificate of Foreign Contracting Party Receiving Federal Procurement Payments, available via the internet at www.irs.gov/w14.
