1.0 PERFORMANCE WORK STATEMENT

The purpose of this firm fixed price purchase order is for the Construction and Installation of Metal grilles and Doors for Residence.

1.1. DESCRIPTION

Provide all equipment and materials to fabricate and install 7 doors and 23 exterior grilles (14 doors grilles and 9 windows grilles) at Métraux 2 Bourdon Residence.

1.2. PERIOD OF PERFORMANCE

The performance period of this contract is from the start date in the Notice to Proceed and should not exceed 2 months.

1.3. GENERAL INSTRUCTIONS

The Contractor shall fabricate 7 doors using specifications below

1. Frame - The door frame to be fabricated in 50x150x4mm hollow section (HS), Mild Steel (MS); with 10x38mm flat-bar door stopper beading. The frame should flow the size of previously removed door opening.
2. Anchors - The frame to go to a depth of at least 50mm below the floor level and fixed T-steel lugs at least 100mm long to the masonry wall. The grill must be welded to lintel reinforcement, with at least two (2) metal bars from the frame to the reinforcement.
3. Door –
 - a. The door panel to be fabricated in Courbaril plain solid core panel, 43mm thick. The wood slats must be jointed with wood dowels and Polyurethane wood glue.
 - b. The Courbaril door must be fitted in 43x30x4mm thick C-channel framing. The Courbaril panel to flash on both sides of the C-channel.

- c. The mild steel flat-sheet, 4mm thick to be welded to C-channel at the rear side of the door. The sheet to be screwed to the solid core Courbaril panel with 1¼”x10 screws in three equal rows at 200mmc/c, counter-sunk, weld-spot and grinded to finish. Also, to be screwed along the front trim at 200mm c/c.
- 4. Hinges - The door to be installed on four 125mm power load hinges type UNION ASSA ABLOY HN-601-U-SSF or approved equivalent.
- 5. Hinge Bolts - Three (3) hinge stoppers (16mmx25mm long) must be installed on the door C-channel.
- 6. Locks –
 - a. A multi bolt security lock type UNION 3301-AA-11 or approved equivalent must be installed. The locks must be installing no higher than 48 inches.
 - b. Two (2) sliding bolts type Sergeant & Greenleaf SM181 must be installed at the middle and bottom. RSO will provide the sliding locks.
- 7. Door Viewer – One (1) wide angle door viewer must be installed to provide one way viewing.
- 8. Finishing –
 - a. All metal parts must be sanded and applied with two coats of primer and auto-paint to match the color of the wooden part.
 - b. The woodwork must be sanded and applied with two (2) coats of wood vanish.

The 23 new wrought iron grilles shall be fabricated and installed on the outside of specified windows and doors which will require removal of existing wrought iron for installation. 6 of the new iron grilles will require the installation of a foot operated escape hatch release for fire escape. All materials of existing metal should be return or left in the ground of the compound.

Grill work will need to meet existing design work or compatible one.

14 of the wrought iron grilles on the 2nd floor will require a thumb drive lockset with a metal tube install around the deadbolt lock that should not interfere with the good function of the wood doors. The grilles on the 2nd floor staircases and balcony use for access and egress install metal screen (expanded metal) a vertical rebar lock to prevent intrusion.

All metal parts must be welded and cleaned of excess slag, sanded, and painted with 2 coats of primer and paint to match existing paint color. A total of 23 grilles will be remove and 23 new grilles will be installed by the contractor.

2.0 MANAGEMENT AND SUPERVISION

2.1 Management. The contractor shall be responsible for the management of the total installation effort. This includes the planning and programming of all services described herein, performance of these services, and compliance with all record and reporting requirements.

2.2 Supervision. The Contractor shall designate a representative who shall be responsible for on-site supervision of the Contractor's workforce. This supervisor shall be the focal point for the Contractor and shall be the point of contact with US EMBASSY personnel. The supervisor shall have supervision as his or her sole function.

2.3 Schedule. The Contractor shall maintain schedules. The schedules shall take into consideration the hours that the staff can effectively perform their services without placing a burden on the security personnel. For those items other than routine daily services, the contractor shall provide the COR with a detailed plan as to the personnel to be used and the period to perform the service. The Contractor shall deliver standard services between the hours of **7:30 AM and 3:30 PM Monday through Friday**.

2.4 Quality Control. The Contractor shall be responsible for quality control. The Contractor shall perform inspection visits to the work site on a regular basis. The Contractor shall coordinate these visits with the COR. These visits shall be surprise inspections to those working on the contract.

3.0 LOCATION

All work shall be done at Métraux 2 Bourdon Residence.

4.0 PERSONNEL

4.1 General.

The Contractor shall maintain discipline at the site and shall take all reasonable precautions to prevent any unlawful, riotous, or disorderly conduct by Contractor employees at the site. The

Contractor shall preserve peace and protect persons and property on site. US EMBASSY reserves the right to direct the Contractor to remove an employee from the worksite for failure to comply with the standards of conduct. The Contractor shall immediately replace such an employee to maintain continuity of services at no additional costs to US EMBASSY.

4.2 Standard of Conduct.

4.2.1 Personal Equipment. The Contractor's employees shall wear clean, neat and complete clothes when on duty and have a valid company identification badge while on the compound. Contractor personnel are prohibited from wearing military style uniforms and/or other military items. Each employee shall be issued a Safety vest while accessing the site.

4.2.2 Identification Cards: All of the Contractor's employees shall have proper identification (ID). Information on the ID card shall include the company name, a photo of the individual, and an employee identification number.

4.2.3 Neglect of duties shall not be condoned. The Contractor shall enforce no sleeping while on duty, unreasonable delays or failures to carry out assigned tasks, conducting personal affairs during duty hours and refusing to render assistance or cooperate in upholding the integrity of the worksite security.

4.2.4 Disorderly conduct, use of abusive or offensive language, quarreling, intimidation by words, actions, or fighting shall not be condoned. Also included is participation in disruptive activities, which interfere with normal and efficient operations.

4.2.5 Intoxicants and Narcotics. The Contractor shall not allow its employees while on duty to possess, sell, consume, or be under the influence of intoxicants, drugs or substances that produce similar effects.

4.2.6 Criminal Actions. Contractor employees may be subject to criminal actions as allowed by law in certain circumstances. These include but are not limited to the following actions:

- Falsification or unlawful concealment, removal, mutilation, or destruction of any official documents or records or concealment of material facts by willful omission from official documents or records.
- Unauthorized use of US EMBASSY property, theft, vandalism, or immoral conduct.
- Unethical or improper use of official authority or credentials.
- Security violations; or organizing or participating in gambling in any form

4.3 Personnel Security

4.3.1 All personnel should have Personal Protective Equipment while working in the compound including boots, safety glasses, gloves, hard hat, fall protection system while accessing the roof of the building

4.3.2 Weapons: Weapons are not permitted on compound. Persons attempting to bring weapons will have their clearance revoked and they may be detained for questioning.

4.3.3 Pilfering/Stealing: Persons attempting to purposefully steal US EMBASSY property will not have access to the compound where project will be completed

4.3.4 Physical Security: The Contractor shall be responsible for safeguarding all property provided for contractor use. At the end of each work period, all facilities, equipment and materials shall be secured.

4.3.5 Contractor Supervisory Personnel:

Contract or Project Managers: The Contractor shall provide the Contracting Officer with the names and telephone numbers of supervisory personnel assigned to handle contract performance issues not less than 5 days prior to the start of this contract.

4.3.6 After award of the contract, the Contractor shall provide the following list of data on each employee who will be working under the contract. The Contractor shall include a list of workers and supervisors assigned to this project. For each individual the list shall include:

Identification number

5.0 MATERIALS, TOOLS AND EQUIPMENT

5.1 The Contractor shall provide proper tools and equipment to perform the work. The Contractor shall also provide all necessary materials to perform the work.

5.2 The contractor will provide all safety personal equipment to his personnel including safety glasses, gloves, boots, hats, mask, or respiratory kit.

6.0 INSURANCE

The Contractor shall obtain any types of insurance required by local law or that are ordinarily or customarily obtained in the location of the work. The limit of such insurance shall be as provided by law or sufficient to meet normal and customary claims.

6.1 Amount of Insurance. The Contractor is required to provide whatever insurance is legally necessary. The Contractor shall, at its own expense, provide and maintain during the entire performance period the insurance to cover his employees for injury or accident.

6.2 General Liability (includes premises/operations, collapse hazard, products, completed operations, contractual, independent contractors, broad form property damage, personal injury)

1. Bodily Injury stated in U.S. Dollars: \$100,000.00
2. Property Damage stated in U.S. Dollars: \$100,000.00

6.3 The types and amounts of insurance are the minimums required. The Contractor shall obtain any other types of insurance required by local law or that are ordinarily or customarily obtained in the location of the work. The limit of such insurance shall be as provided by law or sufficient to meet normal and customary claims.

6.4 For those Contractor employees assigned to this contract who are either United States citizens or direct hire in the United States or its possessions, the Contractor shall provide workers' compensation insurance in accordance with FAR 52.228-3.

6.5 The Contractor agrees that the Government shall not be responsible for personal injuries or for damages to:

- a) any property of the Contractor,
- b) its officers,
- c) agents,
- d) servants,
- e) employees, or
- f) any other person arising from an incident to the Contractor's performance of this contract. The Contractor shall hold harmless and indemnify the Government from any and all claims arising, except in the instance of gross negligence on the part of the Government.

6.6 The Contractor shall obtain adequate insurance for damage to, or theft of, materials and equipment in insurance coverage for loose transit to the site or in storage on or off the site.

6.7 Government as Additional Insured. The general liability policy required of the Contractor shall name "the United States of America, acting by and through the Department of State", as an additional insured with respect to operations performed under this contract.

6.8 Time for Submission of Evidence of Insurance. The Contractor shall provide evidence of the insurance required under this contract within ten (10) calendar days after contract award. The Government may rescind or terminate the contract if the Contractor fails to timely submit insurance certificates identified above.

7.0 POLICIES, REGULATIONS, AND STANDARDS

7.1 Requirements of the Department of State Safety, Health, and Environmental Management Resource Guide include adherence to work practices and procedures stated in applicable codes and regulations. Requirements include obtaining permits, licenses, inspections, releases, similar

documentation, as well as payments, statements, and similar requirements associated with codes and regulations.

7.2 The Contractor shall assume full responsibility and liability for the compliance with all applicable DOS policies, regulations, and standards in their most current form. The Contractor shall hold the U.S. Government and its representatives harmless for failure to comply with any applicable work, hauling, disposal, safety, health or other regulations on the part of the Contractor, their employees, or subcontractors.

7.3 The Contractor shall comply with all local labor laws, regulations, customs and practices pertaining to labor, safety, and similar matters, to the extent that such compliance is not inconsistent with the requirements of this contract.

7.4 The Contractor shall give written assurance to the Contracting Officer that all subcontractors and others performing work on or for the project have obtained all requisite licenses and permits.

7.5 The Contractor shall be responsible for all damages to persons or property that occur as a result of the Contractor's fault or negligence and shall take proper safety and health precautions to protect the work, the workers, the public, and the property of others.

9.0 LAWS AND REGULATIONS

9.1 Without additional expense to the Government, the Contractor shall comply with all laws, codes, ordinances, and regulations required to perform this work. In the event of a conflict among the contract and requirements of local law, the Contractor shall promptly advise the Contracting Officer of the conflict and of the Contractor's proposed course of action for resolution by the Contracting Officer.

9.2 The Contractor shall comply with all local labor laws, regulations, customs and practices pertaining to labor, safety, and similar matters, to the extent that such compliance is not inconsistent with the requirements of this contract.

10.0 WARRANTY

The offeror shall provide a one-year warranty which starts from the date of final acceptance. This requirement shall not modify or change the standard contract warranty agreement.

11.0 PRICING

11.1 VALUE ADDED TAX

Value Added Tax (VAT) is not applicable to this contract and shall not be included in the CLIN rates or Invoices because the U.S. Embassy has a tax exemption certificate from the host government.

12.0 QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

1. SURVEILLANCE. The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.

2. STANDARD. The performance standard is that the Government receives no more than one (1) customer complaint. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212.4, Contract Terms and Conditions-Commercial Items (May 2001), if any of the services exceed the standard.

3. PROCEDURES.

(a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.

(b) The COR will complete appropriate documentation to record the complaint.

(c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.

(d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.

(e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.

(f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.

(g) The COR will consider complaints as resolved unless notified otherwise by the complainant.

(h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.

Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Reasonable inquiry has the meaning provided in the clause [52.204-25](#), Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.

Restricted business operations means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 113-235) and its successor provisions in subsequent appropriations acts (and as extended in continuing resolutions), Government agencies are not permitted to use appropriated (or otherwise made available) funds for contracts with an entity that requires employees or subcontractors of such entity seeking to report waste, fraud, or abuse to sign internal confidentiality agreements or statements prohibiting or otherwise restricting such employees or subcontractors from lawfully reporting such waste, fraud, or abuse to a designated investigative or law enforcement representative of a Federal department or agency authorized to receive such information.

(2) The prohibition in paragraph (u)(1) of this provision does not contravene requirements applicable to Standard Form 312 (Classified Information Nondisclosure

Agreement), Form 4414 (Sensitive Compartmented Information Nondisclosure Agreement), or any other form issued by a Federal department or agency governing the nondisclosure of classified information.

Add the following provision:

52.229-11 Tax on Certain Foreign Procurements—Notice and Representation (JUN 2020)

(a) *Definitions*. As used in this provision—

Foreign person means any person other than a United States person.

Specified Federal procurement payment means any payment made pursuant to a contract with a foreign contracting party that is for goods, manufactured or produced, or services provided in a foreign country that is not a party to an international procurement agreement with the United States. For purposes of the prior sentence, a foreign country does not include an outlying area.

United States person as defined in 26 U.S.C. 7701(a)(30) means—

(1) A citizen or resident of the United States;

(2) A domestic partnership;

(3) A domestic corporation;

(4) Any estate (other than a foreign estate, within the meaning of 26 U.S.C. 701(a)(31)); and

(5) Any trust if—

(i) A court within the United States is able to exercise primary supervision over the administration of the trust; and

(ii) One or more United States persons have the authority to control all substantial decisions of the trust.

(b) Unless exempted, there is a 2 percent tax of the amount of a specified Federal procurement payment on any foreign person receiving such payment. See 26 U.S.C. 5000C and its implementing regulations at 26 CFR 1.5000C-1 through 1.5000C-7.

(c) Exemptions from withholding under this provision are described at 26 CFR 1.5000C-1(d)(5) through (7). The Offeror would claim an exemption from the withholding by using the Department of the Treasury Internal Revenue Service Form W-14, Certificate of Foreign Contracting Party Receiving Federal Procurement Payments, available via the internet at www.irs.gov/w14. Any exemption claimed and self-certified on the IRS Form W-14 is subject to audit by the IRS. Any disputes regarding the imposition and collection of the 26 U.S.C. 5000C tax are adjudicated by the IRS as the 26 U.S.C. 5000C tax is a tax matter, not a contract issue. The IRS Form W-14 is provided to the acquiring agency rather than to the IRS.

(d) For purposes of withholding under 26 U.S.C. 5000C, the Offeror represents that—

(1) It is is not a foreign person; and

(2) If the Offeror indicates “is” in paragraph (d)(1) of this provision, then the Offeror represents that—I am claiming on the IRS Form W-14 a full exemption, or partial or no exemption [*Offeror shall select one*] from the excise tax.

(e) If the Offeror represents it is a foreign person in paragraph (d)(1) of this provision, then—

(1) The clause at FAR 52.229-12, Tax on Certain Foreign Procurements, will be included in any resulting contract; and

(2) The Offeror shall submit with its offer the IRS Form W-14. If the IRS Form W-14 is not submitted with the offer, exemptions will not be applied to any resulting contract and the Government will withhold a full 2 percent of each payment.

(f) If the Offeror selects “is” in paragraph (d)(1) and “partial or no exemption” in paragraph (d)(2) of this provision, the Offeror will be subject to withholding in accordance with the clause at FAR 52.229-12, Tax on Certain Foreign Procurements, in any resulting contract.

- (1) Taking or knowingly agreeing to take any action, with respect to the boycott of Israel by Arab League countries, which Section 8(a) of the Export Administration Act of 1979, as amended (50 U.S.C. 2407(a)) prohibits a United States person from taking; or,
- (2) Discriminating in the award of subcontracts on the basis of religion.
