1. PERFORMANCE WORK STATEMENT

- A. The purpose of this firm fixed price purchase order is to for maintenance services in all designated system and equipment for real property owned or managed by the U.S. Government at U.S. Embassy Port-au-Prince. The price listed below shall include all labor, materials, insurance (see FAR 52.228-3 and 52.228-5), overhead, and profit. The Government will pay the Contractor the total fixed price amount after standard services have been satisfactorily performed.

After contract award and submission of acceptable insurance certificates, the Contracting Officer shall issue a Notice to Proceed. The Notice to Proceed will establish a date (a minimum of ten (10) days from date of contract award unless the Contractor agrees to an earlier date) on which performance shall start.

The performance period of this contract is from the start date in the Notice to Proceed and continuing for twelve (12) months. The initial period of performance includes any transition period authorized under the contract.

- B. The contract will be for a one-year period from the date of the notice to proceed, with a one-year options.

2. PRICING

VALUE ADDED TAX. Value Added Tax (VAT) is not applicable to this contract and shall not be included in the CLIN rates or Invoices because the U.S. Embassy has a tax exemption certificate from the host government.

DESCRIPTION/SPECIFICATIONS/WORK STATEMENT

1. GENERAL INFORMATION

The U.S. Department of State, U.S. Embassy Port au Prince, Haiti requires the contractor to perform, on a regular basis, preventive maintenance of U.S. government-owned gym equipment located at three locations, the U.S. Embassy, the Canne-à-Sucre (CAS) compound at Tabarre 41 and the Stecher Roumain compound on Stecher Roumain Street.

2. WORK REQUIREMENTS

General Requirements:

Work shall normally be performed Monday through Friday during regular Embassy work hours from 7:00 AM to 3:30 PM. Emergency calls should be responded to within 48 hours. Regular preventive maintenance should be provided every month at each location, previously scheduled with Contracting Officer's representative (COR).

Work Requirements:

Contractor must maintain a maintenance logbook at each location, making note of all inspections, repairs and maintenance work performed. All pending maintenance must be recorded, as well as reported to the COR.

A. Contractor must provide all supplies, all necessary tools, personal protective equipment (PPE), materials (excepting new parts), cleaning supplies and labor to provide general preventive maintenance of the gym equipment as follows:

- Vacuum in and around machines and gym equipment. Remove covers to vacuum inside, carefully clean around motors and electronics. CAUTION: Be sure to unplug unit before removing covers since high voltages may still be present.
- Treadmills: clean the belt and deck surface with a cloth.
- Inspect power cords (if present) for damage in the housing or to the outlet prongs
- Inspect all bolts for looseness, tighten as required.
- Inspect all cables and belts for wear or damage.
- Inspect all handles and grips for wear or damage, particularly handle connecting points.
- Inspect all snap links for proper latching or wear.
- Inspect all labeling for readability; this includes placards, warning, and caution decals.
- Inspect all weight stacks for proper alignment and operation
- Inspect cables and grips for wear and replace as needed
- Internal and external cleaning of all the gym equipment.

- Replace all belts and cables if damage or replace if required per the manufacturer recommendation.
 - Lubrication of both internal and external mechanical parts of gym equipment; Wipe all guide rods clean, and lubricate with a lightweight motor oil
 - Regulation in the mechanical and electronic parts of the equipment.
 - Ensure safety, regulation and policy signage is posted
 - Performance test to verify maintenance efficiency.
 - Check for worn cables, belts, and pulleys
 - Check belt tension
 - Re-tighten bike seat, pedals & crank arms
 - Wax and align treadmill running belt & deck
 - Inspect and test product safety features/mechanisms
- B.** If parts need replacement during the preventive maintenance, contractor should have sent the price estimates to COR prior to replacement. The work can only be performed after approval by the contracting officer or after receiving a purchase order for the repair service. Parts must be new and with a minimum warranty of 3 (three) months.
- C.** The contractor is completely responsible for any damage caused by their staff, including subcontractors. All adjacent areas adversely affected by work must be cleaned, repaired, and/or replaced by the Contractor.
- D.** The Contractor shall comply with all local laws regarding work safety. The Contractor is responsible for supplying all individual protective equipment.

3. INSPECTION

The Contractor shall maintain a system of quality control to ensure that the services delivered will meet the requirements of this work order. The USG reserves the right, as provided herein, to inspect all phases of the Contractor's work to ensure requirements are being met.

4. ACCEPTANCE

Acceptance of deliverable services shall be by a USG representative. Accepted work shall be guaranteed for a period of 3 (three) months.

5. PAYMENT

Payment will be made once the work has been accepted, within 30 working days after the invoice is sent for payment. Payment of the parts replaced in the preventive maintenance should be paid to the contractor by the U.S. Embassy. If there is a need for replacement of spare parts, the contractor shall provide prior estimate and request approval of the U.S. Embassy and in case of replacement of parts, payments will be made at the same time as the monthly fee.

6. MAINTENANCE / REPAIR SCHEDULE

The contractor must provide to the COR a maintenance /repair schedule and report after each visit for the gym equipment required to be repair. All repairs or parts replacement must be approved in advance, in writing, by the contracting officer or by a purchase order before the contractor could proceed. The contractor should also report any equipment malfunction or broken items that could affect the safety of the user and cause a risk for personal injury.

(ii) The Offeror (itself or through its immediate owner or highest-level owner) does, does not publicly disclose a quantitative greenhouse gas emissions reduction

goal, i.e., make available on a publicly accessible website a target to reduce absolute emissions or emissions intensity by a specific quantity or percentage.

(iii) A publicly accessible website includes the Offeror's own website or a recognized, third-party greenhouse gas emissions reporting program.

(3) If the Offeror checked "does" in paragraphs (t)(2)(i) or (t)(2)(ii) of this provision, respectively, the Offeror shall provide the publicly accessible website(s) where greenhouse gas emissions and/or reduction goals are reported:_____.

(u)

(1) In accordance with section 743 of Division E, Title VII, of the Consolidated and Further Continuing Appropriations Act, 2015 (Pub. L. 113-235) and its successor provisions in subsequent appropriations acts (and as extended in continuing resolutions), Government agencies are not permitted to use appropriated (or otherwise made available) funds for contracts with an entity that requires employees or subcontractors of such entity seeking to report waste, fraud, or abuse to sign internal confidentiality agreements or statements prohibiting or otherwise restricting such employees or subcontractors from lawfully reporting such waste, fraud, or abuse to a designated investigative or law enforcement representative of a Federal department or agency authorized to receive such information.

(2) The prohibition in paragraph (u)(1) of this provision does not contravene requirements applicable to Standard Form 312 (Classified Information Nondisclosure Agreement), Form 4414 (Sensitive Compartmented Information Nondisclosure Agreement), or any other form issued by a Federal department or agency governing the nondisclosure of classified information.

(3) *Representation.* By submission of its offer, the Offeror represents that it will not require its employees or subcontractors to sign or comply with internal confidentiality agreements or statements prohibiting or otherwise restricting such employees or subcontractors from lawfully reporting waste, fraud, or abuse related to the performance of a Government contract to a designated investigative or law enforcement representative of a Federal department or agency authorized to receive such information (e.g., agency Office of the Inspector General).

(v) *Covered Telecommunications Equipment or Services-Representation.* Section 889(a)(1)(A) and section 889 (a)(1)(B) of Public Law 115-232.

(1) The Offeror shall review the list of excluded parties in the System for Award Management (SAM) (<https://www.sam.gov>) for entities excluded from receiving federal awards for "covered telecommunications equipment or services".

(2) The Offeror represents that—

(i) It does, does not provide covered telecommunications equipment or services as a part of its offered products or services to the Government in the performance of any contract, subcontract, or other contractual instrument.

(ii) After conducting a reasonable inquiry for purposes of this representation, that it does, does not use covered telecommunications equipment or services, or any equipment, system, or service that uses covered telecommunications equipment or services.

52.229-11 TAX ON CERTAIN FOREIGN PROCUREMENTS – NOTICE AND REPRESENTATION (JUN 2020)

(a) *Definitions.* As used in this provision—

Foreign person means any person other than a United States person.

Specified Federal procurement payment means any payment made pursuant to a contract with a foreign contracting party that is for goods, manufactured or produced, or services provided in a foreign country that is not a party to an international procurement agreement with the United States. For purposes of the prior sentence, a foreign country does not include an outlying area.

United States person as defined in 26 U.S.C. 7701(a)(30) means—

- (1) A citizen or resident of the United States;
- (2) A domestic partnership;
- (3) A domestic corporation;
- (4) Any estate (other than a foreign estate, within the meaning of 26 U.S.C. 701(a)(31)); and
- (5) Any trust if—

(i) A court within the United States is able to exercise primary supervision over the administration of the trust; and

(ii) One or more United States persons have the authority to control all substantial decisions of the trust.

(b) Unless exempted, there is a 2 percent tax of the amount of a specified Federal procurement payment on any foreign person receiving such payment. See 26 U.S.C. 5000C and its implementing regulations at 26 CFR 1.5000C-1 through 1.5000C-7.

(c) Exemptions from withholding under this provision are described at 26 CFR 1.5000C-1(d)(5) through (7). The Offeror would claim an exemption from the withholding by using the Department of the Treasury Internal Revenue Service Form W-14, Certificate of Foreign Contracting Party Receiving Federal Procurement Payments, available via the internet at www.irs.gov/w14. Any exemption claimed and self-certified on the IRS Form W-14 is subject to audit by the IRS. Any disputes regarding the imposition and collection of the 26 U.S.C. 5000C

tax are adjudicated by the IRS as the 26 U.S.C. 5000C tax is a tax matter, not a contract issue. The IRS Form W-14 is provided to the acquiring agency rather than to the IRS.

(d) For purposes of withholding under 26 U.S.C. 5000C, the Offeror represents that—

(1) It is is not a foreign person; and

(2) If the Offeror indicates “is” in paragraph (d)(1) of this provision, then the Offeror represents that—I am claiming on the IRS Form W-14 a full exemption, or partial or no exemption [*Offeror shall select one*] from the excise tax.

(e) If the Offeror represents it is a foreign person in paragraph (d)(1) of this provision, then—

(1) The clause at FAR 52.229-12, Tax on Certain Foreign Procurements, will be included in any resulting contract; and

(2) The Offeror shall submit with its offer the IRS Form W-14. If the IRS Form W-14 is not submitted with the offer, exemptions will not be applied to any resulting contract and the Government will withhold a full 2 percent of each payment.

(f) If the Offeror selects “is” in paragraph (d)(1) and “partial or no exemption” in paragraph (d)(2) of this provision, the Offeror will be subject to withholding in accordance with the clause at FAR 52.229-12, Tax on Certain Foreign Procurements, in any resulting contract.

(g) A taxpayer may, for a fee, seek advice from the Internal Revenue Service (IRS) as to the proper tax treatment of a transaction. This is called a private letter ruling. Also, the IRS may publish a revenue ruling, which is an official interpretation by the IRS of the Internal Revenue Code, related statutes, tax treaties, and regulations. A revenue ruling is the conclusion of the IRS on how the law is applied to a specific set of facts.
