**1. PERFORMANCE WORK STATEMENT**

- A. The purpose of this firm fixed price purchase order is for building cleaning services for real property owned or managed by the U.S. Government at U.S. Embassy Port-au-Prince. The price listed below shall include all labor, materials, insurance (see FAR 52.228-3 and 52.228-5), overhead, and profit. The Government will pay the Contractor the total fixed price amount after standard services have been satisfactorily performed.

After contract award and submission of acceptable insurance certificates, the Contracting Officer shall issue a Notice to Proceed. The Notice to Proceed will establish a date (a minimum of ten (10) days from date of contract award unless the Contractor agrees to an earlier date) on which performance shall start.

The performance period of this contract is from the start date in the Notice to Proceed and continuing for twelve (12) months. The initial period of performance includes any transition period authorized under the contract.

- B. The contract will be for a one-year period from the date of the notice to proceed, with a one-year options.

**2. PRICING**

VALUE ADDED TAX. Value Added Tax (VAT) is not applicable to this contract and shall not be included in the CLIN rates or Invoices because the U.S. Embassy has a tax exemption certificate from the host government.

**1.PERFORMANCE WORK STATEMENT**

The purpose of this contract is to obtain power wash and cleaning services for real property owned or managed by the U.S. Government at *U.S. Embassy Port-au-Prince*. The Contractor shall clean all windows, canopies, exterior doors, metallic frames, and power wash the walls and tiles of all the compounds at the Embassy, consular entrance, perimeter walls, main and service entrances. The Contractor shall perform maintenance services for all designated systems and equipment at Stecher Roumain and the Embassy.

**1.2. GENERAL REQUIREMENTS**

Power washing services for walls, canopies, solar panels, metallic frames and window cleaning for major system and equipment installed inside the compound and related to the operation of the U.S. properties are an important part of the representational responsibilities of the U.S. mission. The Government will measure the Contractor's work by the maintenance services provided. These services shall result in all systems being serviced under this agreement being in good operational condition when activated and covered by this contract. The Contractor shall perform complete cleaning services as described in this contract for all Government properties listed in 1.5.

The Contractor shall include all planning, administration, and management necessary to assure that all services comply with the contract, the COR's schedules and instructions, and all applicable laws and regulations. The Contractor shall meet all the standards of performance identified in the contract. The Contractor shall perform all related support functions such as supply, subcontracting, quality control, financial oversight, and maintenance of complete records and files.

**1.3. MANAGEMENT AND SUPERVISION**

1.3.1. SUPERVISION. The Contractor shall designate a representative who shall be always responsible for on-site supervision of the Contractor's workforce. This supervisor shall be the focal point for the Contractor and shall be the point of contact with U.S. Government personnel. The supervisor shall have sufficient English language skill to be able to communicate with

members of the U.S. Government staff. The supervisor shall have supervision as his or her sole function.

1.3.2. SCHEDULES. The Contractor shall maintain work schedules. The schedules shall take into consideration the hours that the staff can effectively perform their services without placing a burden on the security personnel of the Post and also the weather conditions when the tasks will be completed for general safety. The Contractor shall start the work under this contract promptly, execute the work diligently, and achieve final completion and acceptance including final cleanup of the premises within the period specified.

1.3.3. QUALITY CONTROL. The Contractor shall be responsible for quality control. The Contractor shall perform inspection visits to the work site on a regular basis. The Contractor shall coordinate these visits with the COR. These visits shall be surprise inspections to those working on the contract.

#### 1.3.4 TECHNICAL GUIDANCE.

The Contractor shall have the services of qualified personnel with experience in high-rise cleaning and who will cause minimal inconvenience to the US personnel while maintaining the properties. The Contractor shall use adequate numbers of skilled staff who are thoroughly trained and experienced and who are completely familiar with the specified requirements and methods needed for proper performance of the Work.

The Contractor is required to provide a statement that the Contractor's company and all personnel are experienced in windows cleaning and power washing for building more than 20 feet height.

Training for contractor personnel shall include at a minimum:

- 1) Fully understanding of standard operating procedures, safety procedures, quality assurance.
- 2) Recognize the required PPE (Personal Protective Equipment) necessary to avoid the hazards.
- 3) Use of PPE.
- 4) How to use climbing equipment and professional scaffolding harnesses

Training shall be documented and available to the COR.

1.3.5. PERFORMANCE STANDARD. The Contractor shall be required to prepare and submit reports, product literature, quality control schedules, safety plan. These documents shall provide the necessary interfaces, coordination, and communication between the Embassy and Contractor for the delivery of a completed project.

The Contractor shall submit a Cleaning Plan that reflects the required service of this contract. The Plan will be developed to reflect each property and site.

1.3.6 SAFETY AND MATERIALS. The Contractor shall inventory, supply all the necessary equipment and materials for the contract. The Contractor shall maintain a supply of expendable and common parts on site so that these are readily available for normal maintenance to include squeegees, hoses, broom with long handle, etc., in addition to the appropriate tools, and safety equipment.

The Contractor is responsible for maintaining a safe and orderly working environment, proper storage of materials, keeping the areas hazard free, and providing safety shoes, and PPE for technicians (gloves, high-visibility clothing apparel, eyes protection, helmet, anti-slip boots, harness etc..).

Cleaning and safety supplies: The contractor shall inventory the supply after each visit and order replacement supplies when needed to avoid gaps in stock and have them delivered on site. Maintenance materials/supplies shall be in good condition and are to be industry standard and intended for the task to be performed. Parts shall be OEM (Original Equipment Manufacturer) approved.

The employees should always have their safety apparel on when they are on site. Failure to wear those can lead to a temporary stop order until they conform to the contract.

1.3.7 CONTRACT MANAGEMENT by U.S.G.

The U.S.G. will designate a COR (Contracting Officer's Representative) to act as the main point of contact and respond to technical questions that the Contractor may have.

## **1.4. GENERAL REQUIREMENTS**

### **1.4.0 MATERIALS AND EQUIPMENT.**

The Government will supply only the water and from the existing point of connection around the building.

Contractor shall provide adequate quantities of materials in addition to the inventory of materials currently stored at the site to complete the project as specified. Detailed List of Items provided at the site include: Pressure washers, hoses, windows and solar panels cleaning supplies approved by the COR, safety accessories.

All safety materials and equipment incorporated into the project shall be in good condition. The Contractor shall transport and safeguard all materials and equipment required for the cleaning.

### **1.4.1 STANDARD QUALITY.**

The contractor shall consider the following as standards for their cleaning requirements:

- 1- Use the proper anti-slippery equipment and other necessary equipment when doing the high-rise window and solar panels cleaning.
- 2- Avoid using high pressure power wash when cleaning the solar panels, use hosing panels down with low pressure. Avoid cleaning electrical disconnect of the solar panels. The USG is reserved the right to verify the solar panels after the cleaning and claim a reimbursement in case of any physical damage caused by the contractor one (1) month after the last cleaning.
- 3- Weather conditions – When warnings of heavy wind, hurricane, thunderstorms, and heavy rain are issued, the Contractor shall take every practicable precaution to minimize danger to person, the work and adjacent property. Precautions shall include, but not be limited to, closing all openings, removing all loose materials, tools, and equipment from exposed locations, or reschedule the cleaning program with COR's approval.
- 4- Restoration - The surfaces of all unpaved areas disturbed by this project activity shall be sodded with an approved grass native to the sodded area as approved by the COR. These shall include areas where existing sod is killed. Landscape killed or damaged during the cleaning activities shall be replaced with same species and size. Damaged or defective items shall be replaced.
- 5- Cleanup - The Contractor shall keep the work area, including storage areas, free from accumulations of waste materials and comply with all federal, state, and local regulations pertaining to the storage, transport, and disposal of wastes. The Contractor shall not use Embassy waste disposal facilities including garbage cans, trash piles or dumpsters.



- 6- Injury: The Contractor is responsible for safety and shall comply with all local labor laws, regulations, customs and practices pertaining to labor, safety and similar matters. The Contractor shall promptly report all accidents resulting in lost time, disabling, or fatal injuries to the COR.
- 7- At the end of each work day, or notification of a temporary stop order, the Contractor shall lower and fixed all temporary work platforms and/or harnesses. Contractor shall notify the COR of the temporary barricade locations.

#### 1.4.2 REGULAR SERVICE.

The contractor shall prepare the cleaning service plan based on a twice per year service. However, the plan with the dates included shall be shared with the COR for approval at least three (3) days prior to start.

The contractor is responsible for maintaining proper work areas to reduce to minimum to risk of injury, property damage. The contractor shall inspect and perform the following based on regular schedule preestablished by the COR:

- 1- Clean the panels with a glass cleaner to avoid any harsh active components affecting the system, and if any, remove any mold, weeds found under.
- 2-Plan with the COR which windows and solar panels and when they will be cleaned to remove any equipment to might get damaged by the cleaning such as vehicles.
- 3- Do not use high-pressure hose when cleaning as it may cause damage to the panels and clean them smoothly with smooth bristle brush or non-abrasive tissue.
- 4- Consider the weather conditions at least one day before the scheduled cleaning, and if there is a need to postpone, see with the COR based on the weather, when the service can be completed without risks.
- 5- Sweep dirt from the windows frame, rinse and start cleaning. Do not use any chemical glass cleaning products on the windows and doors.
- 6-Rinse the properties with the right pressure to remove any excess of dust, mud or cleaner, and wipe with a squeegee.
- 7-Always use safety cones and caution tapes when working in any areas.
- 8-Removing spider web from the metallic window frames and window corners.
- 9-Clean all stainless-steel doors and metallic doors with appropriate products.

10-Cleaning canopies to include dusting and wiping light fixtures attached. When completed, the light fixtures shall be free from bugs, dirt, grime, dust, and marks.

11-Power washing metallic frames, walls and marble tiles of main building and removing water stain from marble.

#### **4. PERSONNEL REQUIREMENTS**

4.1 GENERAL. The Contractor shall maintain discipline at the site and shall take all reasonable precautions to prevent any unlawful, riotous, or disorderly conduct by Contractor employees at the site. The Contractor shall preserve peace and protect persons and property on site. The Government reserves the right to direct the Contractor to remove an employee from the worksite for failure to comply with the standards of conduct. The Contractor shall immediately replace such an employee to maintain continuity of services at no additional costs to the Government.

#### **4.2 STANDARD OF CONDUCT**

4.2.1 Uniforms and Personal Equipment. The Contractor's employees shall wear clean, neat and complete uniforms when on duty. All employees shall wear uniforms approved by the Contracting Officer's Representative (COR).

4.2.2 Neglect of duties shall not be condoned. The Contractor shall enforce no sleeping while on duty, unreasonable delays, or failures to carry out assigned tasks, conducting personal affairs during duty hours, and refusing to render assistance or cooperate in upholding the integrity of the worksite security.

4.2.3 Disorderly conduct, use of abusive or offensive language, quarreling, intimidation by words, actions, or fighting shall not be condoned. Also included is participation in disruptive activities, which interfere with normal and efficient Government operations.

4.2.4 Intoxicants and Narcotics. The Contractor shall not allow its employees while on duty to possess, sell, consume, or be under the influence of intoxicants, drugs or substances that produce similar effects.

- Criminal Actions. Contractor employees may be subject to criminal actions as allowed by law in certain circumstances. These include but are not limited to the following actions:

- Falsification or unlawful concealment, removal, mutilation, or destruction of any official documents or records or concealment of material facts by willful omission from official documents or records;

- Unauthorized use of Government property, theft, vandalism, or immoral conduct.

- Unethical or improper use of official authority or credentials.

- Security violations; or,

- Organizing or participating in gambling in any form.

4.2.6 KEY CONTROL. The Contractor shall receive secure, issue and account for any keys issued for access to buildings, offices, equipment, gates, etc., for the purposes of this contract. The Contractor shall not duplicate keys without the COR's approval. Where it is determined that the Contractor or its agents have duplicated a key without permission of the COR, the Contractor shall remove the individual(s) responsible from this contract. If the Contractor has lost any such keys, the Contractor shall immediately notify the COR. In either event, the Contractor shall reimburse the Government for the cost of rekeying that portion of the system.

#### 4.3. NOTICE TO THE GOVERNMENT OF LABOR DISPUTES

The Contractor shall inform the COR of any actual or potential labor dispute that is delaying or threatening to delay the timely performance of this contract.

#### 4.4. PERSONNEL SECURITY

4.4.1 After award of the contract, the Contractor shall provide the following list of data on each employee who will be working under the contract. The Contractor shall include a list of workers and supervisors assigned to this project. The Government will run background checks

on these individuals. It is anticipated that security checks will take *[Note to Contracting Officer: Fill in number of days]* days to perform. For each individual the list shall include:

- Full Name
- Place and Date of Birth
- Current Address
- Identification number
- Vehicle plate number and model

4.4.2 Government shall issue identity cards to Contractor personnel, after they are approved. Contractor personnel shall always display identity card(s) on the uniform while providing services under this contract. These identity cards are the property of the US Government. The Contractor is responsible for their return at the end of the contract, when an employee leaves Contractor service, or at the request of the Government. The Government reserves the right to deny access to U.S.-owned and U.S.-operated facilities to any individual.

## **5. MATERIALS AND EQUIPMENT**

The Contractor shall provide all necessary managerial, administrative and direct labor personnel, as well as all transportation, equipment, tools, supplies and materials required to perform inspection, maintenance, and component replacement as required to maintain the systems in accordance with this work statement.

Contractor furnished materials shall include, but not limited to, any material needed to satisfactorily complete and deliver a high-quality product, the materials considered shall be:

Cleaning accessories, different sizes and materials brushes, telescopic poles, vacuum cleaning equipment (vacuum head, vacuum hose, and hose-to- wall fitting items), cleaning chemicals, water treatment chemicals, containers and labels for any substance used, plastic bags and containers to pick-up debris and garbage. The contractor is responsible for removing all waste product to the nearest dumpster and not trash cans located poolside.

## 6. INSURANCE

6.1 AMOUNT OF INSURANCE. The Contractor is required to provide whatever insurance is legally necessary. The Contractor shall, at its own expense, provide and maintain during the entire performance period the following insurance amounts:

6.2 GENERAL LIABILITY (includes premises/operations, collapse hazard, products, completed operations, contractual, independent contractors, broad form property damage, personal injury)

6.3 The types and amounts of insurance are the minimums required. The Contractor shall obtain any other types of insurance required by local law or that are ordinarily or customarily obtained in the location of the work. The limit of such insurance shall be as provided by law or sufficient to meet normal and customary claims.

6.4 For those Contractor employees assigned to this contract who are either United States citizens or direct hire in the United States or its possessions, the Contractor shall provide workers' compensation insurance in accordance with FAR 52.228-3, or host country nationals that do not have a DOL waiver.

6.5 The Contractor agrees that the Government shall not be responsible for personal injuries or for damages to:

- any property of the Contractor,
- its officers,
- agents,
- servants,
- employees, or
- any other person,
- Arising from an incident to the Contractor's performance of this contract. The Contractor shall hold harmless and indemnify the Government from all claims arising, except in the instance of gross negligence on the part of the Government.

6.6 The Contractor shall obtain adequate insurance for damage to, or theft of, materials and equipment in insurance coverage for loose transit to the site or in storage on or off the site.

6.7 Government as Additional Insured. The general liability policy required of the Contractor shall name "the United States of America, acting by and through the Department of State," as an additional insured with respect to operations performed under this contract.

6.8 Time for Submission of Evidence of Insurance. The Contractor shall provide evidence of the insurance required under this contract within ten (10) days after contract award. The Government may rescind or terminate the contract if the Contractor fails to timely submit insurance certificates identified above.

## **7. LAWS AND REGULATIONS**

7.1 Without additional expense to the Government, the Contractor shall comply with all laws, codes, ordinances, and regulations required to perform this work. If there is a conflict between the contract and requirements of local law, the Contractor shall promptly advise the Contracting Officer of the conflict and of the Contractor's proposed course of action for resolution by the Contracting Officer.



7.2 The Contractor shall comply with all local labor laws, regulations, customs and practices pertaining to labor, safety, and similar matters, unless they are inconsistent with the requirements of this contract.

## **8.0. QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)**

(a) **SURVEILLANCE.** The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.

(b) **STANDARD.** The performance standard is that the Government receives no more than one (1) customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212-4, Contract Terms and Conditions-Commercial Items), if any of the services exceed the standard.

(c) **PROCEDURES.**

(1) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.

(2) The COR will complete appropriate documentation to record the complaint.

(3) The COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.

(4) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.

- (5) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.
- (6) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.
- (7) The COR will consider complaints as resolved unless notified otherwise by the complainant.
- (8) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.

*Foreign person* means any person other than a United States person.

*Specified Federal procurement payment* means any payment made pursuant to a contract with a foreign contracting party that is for goods, manufactured or produced, or services provided in a foreign country that is not a party to an international procurement agreement with the United States. For purposes of the prior sentence, a foreign country does not include an outlying area.

*United States person* as defined in 26 U.S.C. 7701(a)(30) means—

- (1) A citizen or resident of the United States;
- (2) A domestic partnership;
- (3) A domestic corporation;
- (4) Any estate (other than a foreign estate, within the meaning of 26 U.S.C. 701(a)(31)); and
- (5) Any trust if—

(i) A court within the United States is able to exercise primary supervision over the administration of the trust; and

(ii) One or more United States persons have the authority to control all substantial decisions of the trust.

(b) Unless exempted, there is a 2 percent tax of the amount of a specified Federal procurement payment on any foreign person receiving such payment. See 26 U.S.C. 5000C and its implementing regulations at 26 CFR 1.5000C-1 through 1.5000C-7.

(c) Exemptions from withholding under this provision are described at 26 CFR 1.5000C-1(d)(5) through (7). The Offeror would claim an exemption from the withholding by using the Department of the Treasury Internal Revenue Service Form W-14, Certificate of Foreign Contracting Party Receiving Federal Procurement Payments, available via the internet at [www.irs.gov/w14](http://www.irs.gov/w14). Any exemption claimed and self-certified on the IRS Form W-14 is subject to audit by the IRS. Any disputes regarding the imposition and collection of the 26 U.S.C. 5000C

tax are adjudicated by the IRS as the 26 U.S.C. 5000C tax is a tax matter, not a contract issue. The IRS Form W-14 is provided to the acquiring agency rather than to the IRS.

(d) For purposes of withholding under 26 U.S.C. 5000C, the Offeror represents that—

(1) It  is  is not a foreign person; and
